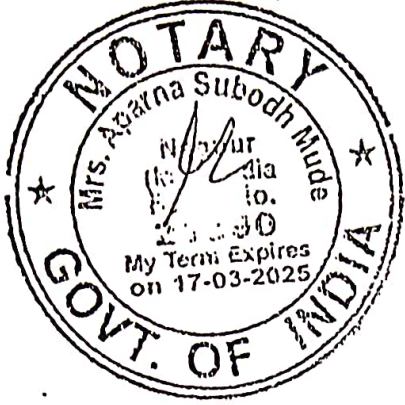

As per the subject under reference, above recognition is being granted by this office to your private primary school, "**South Point Primary School, Ring Road, Nagpur**", Medium : English as a "special case", on "Permanent No Grant Basis" from the current Academic session starting June 2000, subject to the following conditions.

- 1) The society shall be a society registered as per Rules,
- 2) School building and surrounding should be favorable to school, clean and safety.
- 3) Competent staff in the school should be appointed holding age & training (S.S.C. D.Ed.) Educational and vocational qualification stipulated by Govt. from time to time, subject to pay scale as prescribed by the govt. and conditions of service.
- 4) It is necessary to have suitable financial condition material facilities to properly run the school.
- 5) The course prescribed by Govt. from time to time should be complied by the society. Likewise course, test books, evaluation procedure, school programmes and undertakings should be properly implemented and for that all necessary facilities should be supplied.
- 6) The society should have prescribed copy, books for student and should implement in reliable nature.
- 7) It is necessary for the society to maintain educational atmosphere, likewise to create discipline in the students/ Employees, so also impress on their mind the measuring timeliness and regular attendance.
- 8) In future no changes would be made in the medium place of school etc.
- 9) It is necessary for the society to observe the orders, procedure, Rules going to be passed by Govt. from time to time.
- 10) It is necessary for the society to be cautious while admitting students in the school that, no adverse effect will fall on other recognized school in surrounding.
- 11) The permission granted by the Govt. will be treated to have automatically cancelled, if the school is opened & run at the place other than the place for which the Govt. granted permission.

13) Other than the approved class, sections, no class/ additional section shall be started unauthorisedly 14) School time 10.30 to 5 and on Saturday from morning 7 to 12.5 school shall not be assembled in double shift without prior permission. 15) School fees rate shall be as prescribed by Govt. and not more than that (Permission granted to charge fee is Rs. 15/-). 16) It is necessary to Fulfill the conditions prescribed in Mumbai Primary Education Rules, 1949.
